The 2009 Cumulative Supplement replaces the 2009 Supplement, incorporating the information contained in the previous Supplements with the addition of relevant Indiana statutory law through and including the 2014 Legislative Special Session, and relevant Indiana case law through Volume 13 of the North Eastern Third Reporter.

The 2014 Cumulative Supplement is a separate volume and does not replace the CHINS Deskbook 2001 but updates the CHINS Deskbook 2001. The 2014 Cumulative Supplement has its own Table of Contents with outline items bolded to show new information, a separate Index, Appendices, and Forms. Therefore, the CHINS Deskbook 2001 is necessary to understand the 2014 Cumulative Supplement. The CHINS Deskbook 2001 was completed in April 2001 and provides 586 pages of information concerning case law and statutes through the 2000 Indiana General Assembly. Both books contain analyses of cases on Adoption, Guardian ad Litem/Court Appointed Special Advocate, CHINS, Guardianship/Third Party Custody, Paternity Establishment, and Termination of the Parent-Child Relationship.
